(Rupees Two Crore five lakhs only) (Rs.1.64 Cr.-Revenue Component and Rs.0.41 Cr.-Capital Component) in favour of Principal Jawahar Institute of Mountaineering & Winter Sports (JIM&WS) Pahalgam(J&K) as 10% UT Share under detailed head (Grant-in-Aid) for its utilization during the current financial year 2022-23 & 2023-24 with following classification and breakup:-

The sanctioned amount of Rs 2.05 Cr. (Rupees Two Crore & five lakhs only) shall be drawn by Director Finance Tourism Department at Civil Secretariat Treasury Jammu and placed at the disposal of Principal Jawahar Institute of Mountaineering & winter Sports (JIM&WS) Pahalgam (J&K).

This issues with the concurrence of Finance Department conveyed vide No. FD-20/18/2021-03-FD/46546 dated: 22.12.2023 & the amount represent 10% of JKUT share for the period 2022-23&2023-24.

The release of funds shall be subject to the following conditions: -

1. No diversion of funds shall be allowed without prior approval of Competent Authority.
2. The (JIM&WS) shall furnish audited statement of the accounts certified by the Chartered Accountant.
3. The amount shall be spent strictly for the purpose for which it is meant after fulfillment of all the codal provisions as laid down in GFR.
4. The Institute shall furnish utilization Certificate of funds for the current financial year 2022-23.
5. The funds as released are 10% of UT shares both Revex/Capex for the year 2022-23 & 2023-24.
