Administrative Approval is here by accorded to the execution of works taken for Installation of Drag Lift at Sonamarg at an estimated cost of Rs.4.25 Cr. (Rs. Four Cr. and Twenty Five lacs) only as per the schematic breakup given below:-

The Administrative Approval is however subject to the following conditions:-

1. The works shall be taken up in phased manner as per the availability of resources under Capex Budget and no liability shall be created & carried for next financial year. The maximum period of implementation shall be 03years.
2. That the proposals are strictly devised and designed as per latest relevant IS & International codes and specifications and same is authenticated and proof checked by the competent authority (IIT/NIT).While designing, all safety factors, governing the field as per international standards, are followed and adopted.
3. That the Electrical/Mechanical/Electronic Components are authenticated and technically vetted by the competent authorities of relevant field.

4. That the structural design of project is got authenticated and proof checked by the competent authorities well before execution of the works and while designing, latest HFL is also taken into consideration for flood prone locations.
5. That the building plan and other relevant drawings of the project are got authenticated by the Competent Authority well before execution of the works.
6. That the lump sum provisions, either in terms of percentage or fixed as made for certain components of the DPR are provisional and shall be subject to detailed estimates based on actual design details/ requirements and relevant rates, to be framed and approved by competent authority well before invitation of tenders in accordance with set codal procedures.
7. That the specifications as applicable under rules and procedures for the proposed type of structure shall be adhered to. It must also be ensured that there shall be no multi- source of funding or overlapping of schemes under different programmes.
8. That there is no time or cost overrun involved in the project and set time line is strictly adhered to.
9. That the NOCs from all Regulatory Authorities are sought before the commencement of works.
10. That encumbrance free land is available for execution of the project.
11. **That e-tendering mode is followed for fixation of award of contract for execution of the project and working DPR is followed in the formation of BOQ for e-tendering purpose of the project. Fragmentation of the project components into multiple allotments shall be strictly avoided while tendering the works.**
12. **The accord of Administrative Approval shall not however, be treated as authority:-**
  - i. **To spend money not provide for in the Budget.**
  - ii. **To create new post, if any provided for in the Administrative Approval.**
13. **The executing agency/controlling officer shall ensure that no components or part of components included in the project has been executed earlier under any of the programme including PMDP/Internal resources.**


