4. That the lump-sum provisions, either in terms of percentage or fixed as made for certain components well before invitation of tenders in accordance with set codal procedures.

 That the specifications as applicable under rules and procedures for the proposed shall be adhered to. It must also be ensured that there shall be no multi- source of funding or overlapping of schemes under different programs.

6. That there is no time or cost overrun involved in the purchase of

machinery and set time line is strictly adhered to.

7. That e-tendering mode is followed for fixation of award of contract for execution and the purchase is followed in the formation of BOQ for etendering purpose of the project. Fragmentation of the project, components into multiple allotments shall be strictly avoided while tendering the works.
