Government Order No. 26 – JK(TSM) of 2022 D A T E D:- 11 - 03 - 2022

Sanction is hereby accorded to the constitution of a committee comprising of following officers to conduct detailed enquiry into the execution of works under PMDP by Directorate of Tourism, Kashmir.

- d. Accounts officer, Sonamarg Development Authority.

The terms of reference of the committee shall be as under:-

- i. Whether all codal formalities like AA/TS was obtained.
- ii. Whether works have been executed through proper tendering process.
- iii. Whether works have been executed strictly as per approved DPR.
- iv. Whether utilization of funds have been strictly as per the authorization conveyed by Adm. Department.
- v. Whether the physical status of works on site is commensurating with the DPR and allotment orders.
- vi. Whether there has been any mis-appropriation or re-appropriation.
- vii. Whether any extension/approval granted beyond the allotment order or as per the standing norms/rules issued by the PWD/Finance Department from time to time.
- viii. To identify the officer/officials in case any violation/re-appropriation/misappropriation has been done in the existing norms/rules governing the execution of works.
- ix. Any other issue the committee may like to deliberate upon.

Besides, the committee will also enquire if any scheme / work have been funded through multiple sources of funding. The Committee will also physically inspect the works executed at site.

The committee shall be submitted its report within 15 days positively along with its recommendations.
