**The release of funds shall be subject to the following conditions that: -**

01. The expenditure shall be made strictly as per the guidelines issued by the Finance Department vide Circular No. FD- VII- Gen (110) 2009-10-11 dated 09.07.2020 according to the classification under which funds have been authorized by the
02. The expenditure shall be made strictly according to the classification under which funds have been authorized by the Finance Department. No diversions shall be made unless specifically and separately authorized.

K.T.O

03. The Treasury Officer shall not entertain bill without complete classification under which funds have been placed with the Treasury.
04. There should be Uniform expenditure under each object head to avoid rush of expenditure during the last quarter of the financial year.
05. The Secretary, Jammu Tawi Golf Course shall observe all codal formalities before making any payment.
06. The Treasury Officer shall not allow parking or drawal of funds in the Civil Deposit without the prior concurrence of the Department
07. The Secretary, Jammu Tawi Golf Course shall be duty bound to ensure submission of audited items, detailed Utilization Certificate of the sanctioned amount to the Administrative Department on 5<sup>th</sup> of every succeeding month.
08. The Secretary, Jammu Tawi Golf Course shall conduct periodic reconciliation of remittances and drawals with the Treasury and the Office of the Accountant General (A&E) J&K to ensure correct reflection of income and expenditure in the Finance and other Accounts.
09. The Secretary, Jammu Tawi Golf Course shall strictly inspect and supervise the public receipts and expenditure with reference to the Appropriation Act 2021 and all the standing rules and regulations.
10. All the sanctions/ approvals and clearances shall be in place, before drawal of money from the Treasury.
11. Administrative/ Technical sanction wherever required in respect of works should be obtained from the competent authority before the expenditure is incurred.
12. The Secretary, Jammu Tawi Golf Course shall ensure that the expenditure under various object heads is contained within the budget allocation.
13. The Secretary, Jammu Tawi Golf Course shall ensure that the expenditure is supported by an act of sanction of authority competent to sanction such expenditure.


