05. All the procurement of Goods and Services shall be made through GeM portal in terms of relevant provisions of GFR 2017. Manual for procurement of Goods 2017 and Manual for Procurement of consultancy and other Services 2017.

06. There should be Uniform expenditure under each object head to avoid rush of expenditure during the last quarter of the financial year.

 The Executive Director, Mubarak Mandi Jammu Heritage Society shall observe all codal formalities before making any payment.

08. The Treasury Officer shall not allow parking or drawal of funds in the Civil Deposit without the prior concurrence of the Department

- 09. The Executive Director, Mubarak Mandi Jammu Heritage Society shall be duty bound to ensure submission of audited items, detailed Utilization Certificate of the sanctioned amount to the Administrative Department on 5<sup>th</sup> of every succeeding month.
- 10. The Executive Director, Mubarak Mandi Jammu Heritage Society shall conduct periodic reconciliation of remittances and drawals with the Treasury and the Office of the Accountant General (A&E) J&K to ensure correct reflection of income and expenditure in the Finance and other Accounts.

 The Executive Director, Mubarak Mandi Jammu Heritage Society shall strictly inspect and supervise the public receipts and expenditure with reference to the J&K Appropriation (No.2) Act 2021 No. 9 of 2021 dated 25<sup>th</sup> March 2021.

 Administrative/ Technical sanction wherever required in respect of works should be obtained from the competent authority before the expenditure is incurred.

 The Executive Director, Mubarak Mandi Jammu Heritage Society shall ensure that the expenditure under various object heads is contained within the budget allocation.

14. The Executive Director, Mubarak Mandi Jammu Heritage Society shall ensure that the expenditure is supported by an act of sanction of authority competent to sanction such expenditure.
