- 2. Providing facilities to the pilgrims/devotees;

- Undertaking the developmental activities concerning the areas of the Shrine and its surrounding out of the funds of the Shrine, aimed to facilitate the pilgrimage of the devotees;
- 5. Making provision for medical relief of the worshippers and pilgrims; and
- Doing all such things as may be identical to and conductive for the efficient management, maintenance and administration of the Shrine and the Shrine fund and for convenience of the pilgrims.
